
VFC Children's Holiday Party & Gift Cards



Ways to Give

Year-End Tax Planning and IRAs

Taxpayers who itemize deductions have until December 31, 2023, to make charitable contributions for their 2023 tax years. Moreover, those 70½ and older can use their individual retirement accounts (IRAs) to support Voices for Children. An IRA charitable rollover gift to Voices for Children may lower income taxes, satisfy the minimum distribution for the year, reduce taxable income even for those who do not itemize deductions, and more.
